### DIAC Evening Meeting at K of C – Wyandotte, MI

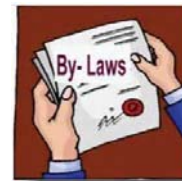

There is no cost for the snack, but you must make your reservation by calling **Sam Randazzo** at (734)676-8463, no later than **Wednesday, November 20.**

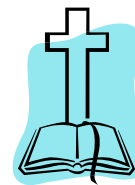
### Amending the Club By-Laws

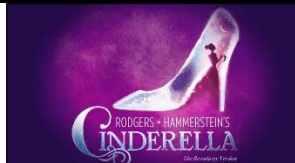
## Genitti's Hole-in-the-Wall – Dec. 5, 2019

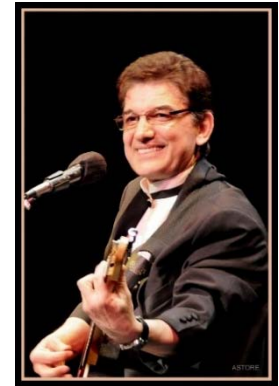

## PROPOSED BY-LAW CHANGES OF NOVEMBER 24, 2019

### CONSTITUTION - ARTICLE III - MEMBERSHIP

#### Original Wording:

Membership in the club shall be open to all families who have Italian ancestry by blood, from either maternal or paternal side, and any person who is related through marriage to a person of Italian ancestry, and who are basically in accord with the purposes above described, who qualify in compliance with the governing by-laws hereinafter provided, with final acceptance by the General Assembly. ~~In the event of the death of the member of Italian ancestry, the (non-Italian spouse) remaining member shall continue as a member, but for as long as said member does not remarry a person other than of Italian ancestry, by blood, If such member remarries a non-Italian spouse, they both qualify for the status of Associate Members.~~

#### Proposed Wording Change:

**Membership in the Club shall be open to all families who have Italian ancestry, from either maternal or paternal side, and any person who is related through marriage to a person of Italian ancestry, and who are basically in accord with the purpose and above described, and who in compliance with the governing By-Laws hereinafter provided, and Club Policies, with final acceptance by the General Assembly.**

Note:

The balance of the paragraph (and any additions/deletions) will be added to the Club Policy Handbook

The following (below) is moved from the **BY-LAWS: ARTICLE I, MEMBERSHIP, SECTION D**, To this section.

**An Honorary Member is one who shall have attained twenty-five (25) continuous years in the Club in good standing. Such members shall have all the rights enjoyed by a regular member.**

Note:

The balance of the paragraph (and any additions/deletions) will be added to the Club Policy Handbook

### CONSTITUTION - ARTICLE V- MEETINGS

#### Original Wording:

Other than a meeting of elections, there shall be monthly meetings of the Board and Membership, with exception of July and August, and such special ones as the occasion requires, all of which shall be conducted as hereinafter provided in the By-Laws.

#### Proposed Wording Change:

**Other than a meeting of elections, there shall be monthly meetings of the Board and Membership, at the discretion of the current administration, including date, time and location of such meetings, and such special ones as the occasion requires, all of which shall be conducted as hereinafter provided in the By-Laws.**

### BY-LAWS - ARTICLE I - MEMBERSHIP

#### Original Wording:

Section 1. One interested in becoming a member of the Club, may do so upon filing an application, sponsored by one regular member, with the Membership Committee, together with the attendant fees required, and in due course, within thirty (30) days from filing, and after proper investigation, a report thereof, with recommendations, shall be made by the membership committee to the General Membership for its acceptance.

#### Proposed Wording Change:

**Section 1. One interested in becoming a member of the Club, may do so upon filling an application sponsored by one regular member, to the Membership Committee, together with proper dues and fees; accepted by the Club Board with final acceptance by the General Assembly.**

The balance of the above Sections and paragraphs following will be deleted from the Club By-Laws and added to the Club Policy Handbook

~~Section 2. The Classification of Membership shall be:~~

~~–A. A Regular Member shall be a husband and wife, or a single person, who shall qualify under Article III of the Constitution, and both husband and wife, or single person, shall have the right to voice, vote and hold office, and shall be in good standing with respect to all dues and assessments. No person shall be eligible to be a member of the Club until he shall have attained the age of eighteen years. However, he shall be entitled to attend and participate in all social activities that are derived from the membership of his parents.~~

~~–B. An Associate Member shall be a (husband and wife), or a single person, who is not married, who shall qualify under Article III of the Constitution, and both (husband and wife) or single person, shall be in good standing concerning all dues and assessments. No person shall be eligible to be a member of the club until he/she has attained the age of 18 years. However, he/she shall be entitled to attend and participate in all social activities that are derived from the membership of his/her parents. The Associate Membership limit shall be determined from time to time by the Club Board and the approval of the General Assembly.~~

~~–C. A Single Person in good standing shall have the right to participate in all Club functions but must incur the cost of his or her partner.~~

~~–D. An Honorary Member is one who shall have attained twenty-five (25) continuous years in the Club in good standing. Such member shall have all the rights enjoyed by a regular member. Dues and/or assessments shall be such as is determined from time to time by the Club Board and approved by the members in good standing. The amounts and terms of said dues and assessments shall be contained in the minutes of the meeting prior to the increase and the rates shall prevail until otherwise changed.~~

~~–E. An Emeritus Officer is one who has been granted such privilege by a vote of the General Assembly. This position shall be held only by ex-officers who have served the Club creditably for a long period of time. This office shall be held by only one member at any one time. It may be filled again only when the preceding Emeritus Officer dies or permanently retires from the Club. An Emeritus Officer shall retain the rights of a regular member but shall not pay dues. He shall have the rights to vote at Board and General Meetings. He shall have the right to hold office but gives up the Emeritus during his term in office.~~

~~–F. Whenever the term “He” is cited in the By-Laws, it shall be understood to mean he or she.~~

~~–G. An individual who becomes a member, through marriage to a Club member, his/her membership date shall be recorded as the date of their marriage.~~

## **BY-LAWS - ARTICLE X – MEETINGS AND QUORUMS**

### **Original Wording:**

**Section 1.** In addition to the election meeting above, there shall be a regular monthly meeting, with the exception of July and August. A special meeting may be called at any other time by the President or by a majority of the Club Board.

### **Proposed Change:**

**Section 1.** In addition to the election meeting above, there shall be monthly meetings of the Board and Membership, at the discretion of the current administration, including date, time and location of such meetings, and such special ones as the occasion requires, all of which shall be conducted as hereinafter provided in the By-Laws.
